

QUORUM AND VOTING RESULTS

The Annual General Meeting of Sacyr, S.A. held on 13 June 2024 on second call was attended (directly or through representatives), including the company's treasury shares, by 663 shareholders, holders of 439,416,470 shares of the Company, representing 57.645% cent of the subscribed share capital with voting rights. Of which:

- In person attendance amounted 134 shareholders, holders of 65,665,017 shares, representing 8.614% of the share capital.
- Attendance by proxy amounted 529 shareholders, holders of 373,751,453 shares, representing 49.030% of the share capital.

The issued share capital amounts to EUR 762,286,580 and is divided into 762,286,580 shares of EUR 1 par value each.

The company's Treasury shares amounts to 5,592,645 shares equivalent to 0,734% of the issued share capital.
